## **Job Description**

**Purpose of Job:** To provide high quality, effective support to children, schools and families and promote positive outcomes for children and young people with complex needs.

#### Who we are:

Alpha Inclusion and Communication (AlphaIC) is a Social Enterprise with its main office in Hethel, Norwich, Norfolk. We work with neurodivergent individuals and alongside schools and businesses to improve accessibility and inclusion in education and the workplace.

# About the roles:

Our services are in high demand and we're still growing. We need practitioners to support both peripatetic work across Norfolk and Suffolk.

**Contract:** Minimum of 4 days per week. £21,000 - £27,500 per annum depending on additional responsibilities. Flexible working across the week considered and flexible contracts available (term time + 3 weeks or 52 weeks).

## Main Responsibilities: (Outreach Practitioner Roles x 3)

- Plan, develop and deliver interventions for individuals and groups of children and young people in schools and families, across Norfolk and Suffolk and via online platforms
- Provide support to schools and families in order to improve outcomes of children and young people with diverse and complex needs.
- Liaise with professionals in schools and settings in order to ensure a co-ordinated approach in support of children and their families.
- When needed, the transportation of children and young people.
- Monitor and report progress of pupils on caseload and demonstrate the effectiveness of support.
- Attend regular meetings with other colleagues.
- Attend regular one to one sessions and be responsible for being proactive in self reflection and continuous development.
- Comply with Alpha Inclusion regulations and policies to ensure safe and professional practice.
- Contribute to the culture and support of the team, carrying out other duties as needed.
- Commit to ongoing personal and professional development to ensure services remain effective and up-to-date with current practice and legislation.
